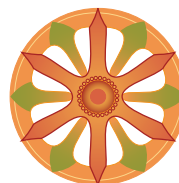

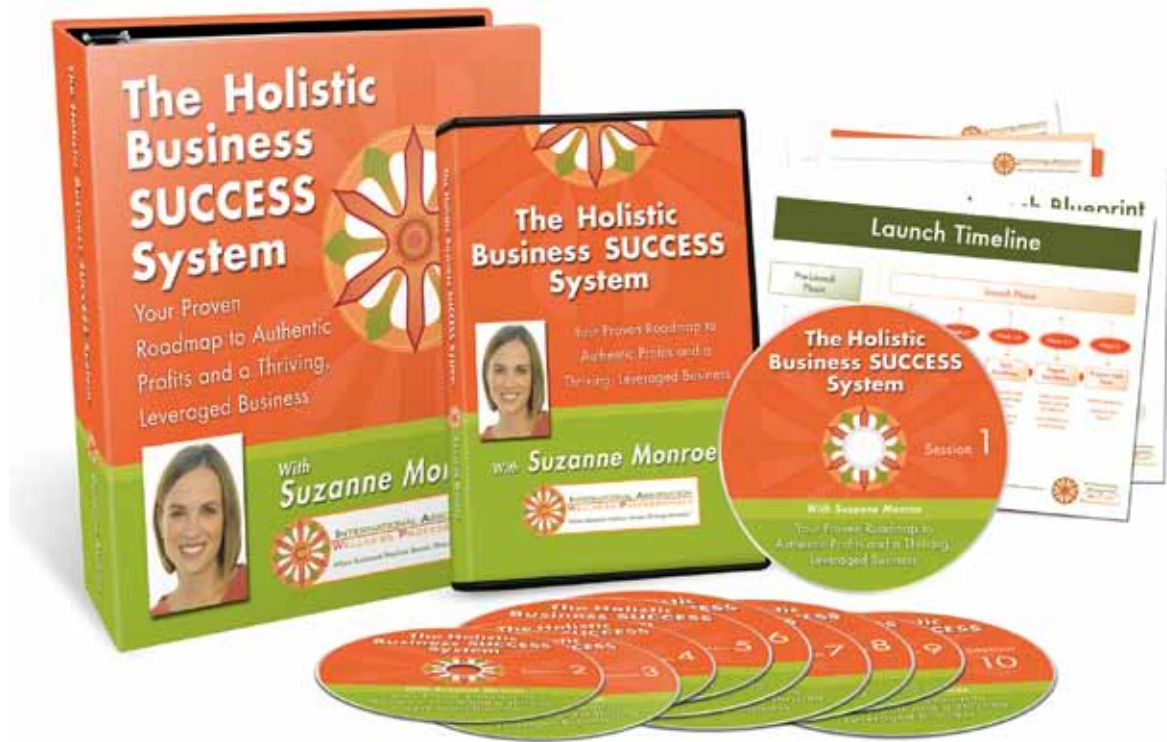

Governing Law/Force Majeure/Severability/Notices/Assignment
